The Tecumseh Local Board of Education met in regular session on September 25, 2018 with board president, Peter Scarff presiding. Mr. Scarff called the meeting to order at 6:00 p.m. The meeting was held in the Special Education Conference Room at Tecumseh Middle School, 10000 West National Road, New Carlisle, Ohio 45344.

- Brian Dixon, Tecumseh Middle School Principal, introduced teachers Mrs. Sara Nelson and Mrs. Jennifer Hulbert. Mrs. Nelson shared information regarding a multiple genre project and how she was looking for ways to make writing meaningful. She introduced students Alec Herbert, Mason Holt, and Xavier Prenatt who gave reports on their Google site projects. The platform allows for collaborative learning through sharing Google documents with another classmate or multiple users on one document. Teachers can get immediate feedback and support while working in the classroom and can toggle between and communicate through Google with individual students with the added benefit of not having to single out a student individually while avoiding calling attention to themselves. This gets students excited about writing. The teachers and students were invited to return in the spring to share their finished projects.
- Superintendent Paula Crew provided data on pay to participate. An option to eliminate pay to participate would entail paying the entire amount out of the general fund. Pay to participate information for all of Clark County indicates that Tecumseh charges the most. Athletic Director Craig Eier clarified that he does not want pay to participate and it should be part of public education. He noted that it affects the number of students who participate but we don't know who those students are. Discussion included cost containment measures in Phase I and Phase II cuts, expenses paid by the general fund versus boosters, increased costs, safety concerns and the ongoing need for updated equipment. It was noted that information needs to be collected and more consideration and discussion needs to be done.

OSBA fall conference is November 11-13, 2018. Mrs. Crew would like to remain in the district on Monday, November 12, to participate in activities honoring the district's veterans.

# Legislative Update

- Senate Bill 216 Currently third grade reading and math tests are administered electronically. But in the 2019-2020 school year, third grade reading and math tests can be given on paper if the board passes a resolution to do so.
- Teacher Evaluation The OTES committee will take a look at changes that take out the student achievement factor so teacher evaluations are not determined by how students perform on state tests.
- The safety law had passed and money may be available for safety and security for School Resource Officers but the money can't supplant anything already done. That has now been changed, and we will get that funding now. The amount the district will receive has not been determined, but information available shows amounts starting at a minimum of \$2,500.

# Superintendent's Report

- The Tim Kight and R Factor inservice was Friday. He was really good. Great verbal feedback was received through texts and emails. Susan Wile noted that a formal survey included very few negative comments, and the comments received have been the best following an inservice, with many asking for more information.
- Strategic Planning The first meeting is October 11. Over 500 people responded to the survey which is an extremely high response according to OSBA.
- State School Board –The Department of Education has been contacted by groups asking the state for help in determining whether to ban Indian nicknames by school districts. Mrs. Crew has also been contacted by the media regarding this. Nineteen high schools in the region use Native American-related nicknames. Mrs. Crew has contacted local resident Bill Berry regarding the history of the district's name change to Tecumseh. Currently the Department of Education is going to leave it up to local school districts regarding their name, but they will continue to research it.
- A grant has been awarded by the National Alliance on Mental Illness that will help the district to provide training on mental health and trauma sensitive situations.
- There are four levy renewals coming up that need to be discussed. Mrs. Crew will have information gathered and ready to share at the next meeting. An attorney from

Bricker and Eckler that specializes in levies will be available in November to discuss the levies.

Clark County has the capability of putting a county-wide levy on the ballot for a certain length of time, short-term or indefinitely, for safety and security, School Resource Officers. The levy would generate approximately \$147,000 annually, 1 mil for Tecumseh Local. A survey was sent to county school district superintendents and treasurers. The responses indicate that 75% of districts believe the best time to put this levy on the ballot would be May 2019, and 57% of districts prefer 1 mill over .5 mill. For the length of the levy, 71% of district preferred an ongoing, continuing levy as opposed to five or ten years. The survey also inquired about SB318 funding affecting district interest in the levy as well as the districts plans for use of the money generated. Tecumseh's preliminary plans would be to use the money for our School Resource Officer and possibly offset mental health services. County superintendents and treasurers will be meeting the first Friday of October to further discuss this.

# Assistant Superintendent's Report

- We worked with the Clark County Emergency Management with a Memorandum of Understanding that in the event of a natural disaster event they would be able to use our busses for non-school related activities as well as our buildings.
- Ray Peyton of juvenile court was contacted regarding potentially using juvenile court for mediation this year. There would be no cost unless we have situation of an unruly child or truancy issue we can't handle in-house, and we could have that at the juvenile court resource building. We have used them in past years, but not recently. Mr. Gehret doesn't foresee using them very often, just when there is a legitimate need.
- Mr. Gehret echoed that Tim Kight's presentation was good. He rolled out the program in a manner that we couldn't have done justice to like Mr. Kight did.

# **Treasurer's Report**

- After the booster handbook is completed, the treasurer's office will work on ACH deposits of employee checks that will be prepared for staff reimbursements for items such as cell phones or supplies. These reimbursements would then be direct deposited like payroll checks. This is helping the district to go electronic and paperless.
- The Clark County auditor's office sent a notice saying they are refunding a million dollars back to Clark County governmental entities. Tecumseh is expected to receive \$74,191.85, some designated to the bond fund, some to the permanent improvement fund. This money is from a county assessment fund. The county takes a little bit of the property tax revenue and puts it in the assessment fund and the fund is used to help with reappraisals. At times, when the fund gets a large amount of excess money, the county auditor may decide to pay out the money to reduce the fund or they have the option to keep the money. The county auditor determines which funds the district will deposit the funds to.
- EZpay reports from August 1 to today and the same time frame last year show: \$24,400 2017, and \$47,300 2018. This is almost double.

# **Special Education Director's Report**

- Susan Wile shared that she attended the Gifted Updates meeting in Columbus last week and was in Columbus again today for the Fall Migrant Inservice.
- There have been lots of IEP meetings and student meetings.
- Mrs. Wile is excited about the Tim Kight presentation and the upcoming Tecumseh Tech Day.

- Mrs. Brents shared a comment an employee had made to her that there has been a complete shift in what she deemed as the entire district as far as positivity. The employee thanked her for the decisions that have been made.
- Mrs. Slagell participated in Making Middle Grades Work Site Review this past month. It was great. She interviewed students and gathered information that will be helpful for strategic planning.
- Ms. Martin noted the Homecoming weekend and the Heritage of Flight Festival will take place during October 5-7. She has done the Air Force 5K run the last three years and loved seeing Tecumseh students with MSgt Ruiz and Major Couch manning the bag check and commented on their kindness and politeness, representing our district well.
- Mrs. Scott noted that CTC enrollment is the highest it has been in many years, up about 50 from last year to 713. CTC Executive Director Chris James had discussed with Mrs. Scott that we don't send 8<sup>th</sup> graders to CTC and offered to help with that. CTC carpentry students are rebuilding the dog barn at the fairgrounds. We currently have about 113 students at CTC, Springfield has 124, Shawnee has 135 those are the top three schools at CTC. The Band Showcase is this Saturday. The Goodwill truck is outside for donations; it is a fundraiser for the Band Boosters. The parking spot painting is fantastic and the artwork is great. We did have Girl Scout and Boy Scout recruiting in the schools. She appreciates use of the building for recruiting. She asked for clarification regarding the number of Clark State scholarships, there are ten, not forty.
- Mr. Scarff noted the presentation by the middle school kids tonight was awesome and agreed they should return in the spring with their finished projects. The Heritage of

Flight parade, that board members normally participate in, is October 6. The parade starts at 11:00. Mrs. Crew is inviting the administrative team and providing candy to distribute.
