Mrs. Scott called the meeting to order at 5:30 p.m. The meeting was held in the Arrow Conference Room at Tecumseh High School, 9830 W. National Road, New Carlisle, Ohio 45344.

Roll Call: Present — Members Scott, Martin, Brents, Slagell, and Priest. Absent — None.

Mrs. Scott led the Pledge of Allegiance.

## Minutes of Previous Meetings

## **Communications**

Other Communications – Mrs. Crew recognized board members for Board Member Appreciation Month and presented them with Certificates of Appreciation. Reports:

- Lisa Burleson with Walter | Haverfield, Attorneys at Law Food Service Legal Opinion: Presented information on Child Nutrition Services policies and procedures and the need to be detailed as to the district policies and practices. Child Nutrition Services is under the purview of the U.S. Department of Agriculture and Ohio Department of Education. Donations made to the district become district funds and can only be used to pay bad debts that are uncollectable, not something that is delinquent. Uncollectable bad debt becomes an operating loss of Child Nutrition Services. Donated funds must be used to benefit all students proportionately. Donations cannot be earmarked for specific students. The district can work through PTO organizations (501c3) to accept donations, and donors can write off their donations. The donations can be used to pay delinquent meal charges once they are proven to be uncollectable and become bad debt. The Free and Reduced Meal Program is the safety net that should be used to prevent delinquent meal charging when possible.
- Paula Crew Ed Choice: Information was presented regarding HB166 budget bill amendments. Students in grades 9-12 who never attended a public school in their district of residence can receive a voucher if that school is on the Ed Choice list. Students in grades K-8 must attend the public school for a certain period of time before receiving a voucher; districts can determine that length of time. Ed Choice diverts tax dollars away from our school system sending it to private and parochial schools. A recent Springfield News-Sun article reported that Tecumseh is on the Ed Choice bad school list; a phone call was made to share our disagreement. Twenty-Two

Clark County schools were included on the list. Schools get on the "bad list" due to performance, graduation rate, lowest 10% in Ohio, literacy, and overall district performance. Ed Choice providers - 496 nonpublic schools have applied to be ED Choice providers. Concerns regarding Ed Choice: reduction in funding, selective admission policies by private schools (not inclusion), private school are not subject to testing standards public schools follow, and private schools do not have to share their test scores. This equates to unfunded mandate. There is a training on January 30 to walk through the process. Impact on budget planning is undetermined.

Resolution Opposing the State of Ohio EdChoice Scholarships (Voucher) Program Motion by Ms. Martin and second by Mr. Priest to adopt the Resolution Opposing the State of Ohio EdChoice Scholarship (Voucher) Program, as presented.

## RESOLUTION OPPOSING THE STATE OF OHIO EDCHOICE SCHOLARSHIP (VOUCHER) PROGRAM

WHEREAS, the Ohio legislature has recently made amendments which greatly increase the number and availability of vouchers for students to attend private/parochial schools at public tax expense, and

WHEREAS, such vouchers will be available to numerous families and students who have never attended Tecumseh Local or any other public schools and for whom state funding has never been provided to Tecumseh Local or any other public schools, and

WHEREAS, Tecumseh Local's state funding will be unjustly decreased by the amount of the vouchers provided to such families and students who have not and will not attend public schools and others who transfer to private/parochial schools, and

WHEREAS, the loss of revenue to the Tecumseh Local School District would devastate the District's finances, and

WHEREAS, private/parochial schools accepting students with public tax vouchers would not be required to accept all students but would be permitted to retain their selective admission policies without enforcement of other laws applicable to public schools, and

WHEREAS, private/parochial school students are not subject to the testing standards required of public-school students so that the actual performance of private/parochial schools subsidized with public tax dollars will not be known, relative to equivalent public-school evaluation standards, and

WHEREAS, this Board believes that the EdChoice voucher program as it currently exists presents serious constitutional issues regarding the separation of church and state and the funding of religious institutions with public tax dollars, and

WHEREAS, the State of Ohio has the constitutional responsibility to secure a thorough and efficient system of common schools, and

WHEREAS, the EdChoice voucher program will have exactly the opposite effect by providing funding to private/parochial schools at the expense and to the detriment of public schools and their students.

NOW, THEREFORE, BE IT RESOLVED by this Tecumseh Local School District Board of Education that this Board reaffirms its commitment to free accessible public schools which are adequately and equitably funded to guarantee a comparable education for ALL children and therefore opposes and respectfully requests the repeal of the ill-conceived EdChoice voucher program of the State of Ohio.

BE IT FURTHER RESOLVED that this Board opposes any funding programs, vouchers or otherwise, that have the effect of diverting public tax dollars from public schools to private/parochial schools.

BE IT FURTHER RESOLVED that the Treasurer is hereby authorized and directed to forward copies of this Resolution to all Ohio state legislators, the Superintendent of Public Instruction and Governor of the State of Ohio.

- Child Nutrition Services provided the following meals in December 2019: nearly 12,000 free lunches, 2,600 reduced-price lunches, 6,500 free breakfasts and 1,264 reduced-price breakfasts.
