The Tecumseh Local Board of Education met in regular session on February 25, 2020 with board president Corinne Scott presiding. Mrs. Scott called the meeting to order at 6:00 p.m. The meeting was held in the New Carlisle Elementary School Library, 1203 Kennison Ave., New Carlisle, Ohio 45344.

#### **Communications**

- Beth Freeman, New Carlisle Public Library presented the annual report to the board. The library was organized in 1932 as an Association library with no taxing authority. When the library needs additional funds, a signed contract allows the library to "borrow" the Tecumseh Local taxing authority. The library has implemented increased hours to 60.5 hours a 16% increase, increasing 7% in individual library visits and a 6% increase in circulation. On February 17, 2019 the library became fine-free. Patrons are still billed for lost items, and expensive items, such as telescopes and mandolins, are still fined. Past overdue fees have been forgiven. In March 2019, the library began offering hoopla, a platform for ebooks, audio books, movies, tv shows, etc.; 274 individuals have registered with hoopla and checked out 2,463 items. The library is planning for long-term improvements and is looking to completely remodel the children's department. The library boundary is around the City of New Carlisle, a little of Bethel Township and a little of Pike Township. Tax revenue flows through the district and the money is transferred to the library.
- Nate Lasso, Director of Student Services and Academics at CTC shared information regarding the CTC program and CCP opportunities, and he thanked the board for

- Tecumseh's partnership. Student Miriham DeBlas shared her experiences at CTC and the benefits of attending CTC and receiving college credit while in high school. Her class passed their STNA state board exams.
- Kathryn Randenburg, Principal, New Carlisle Elementary School reported on the sensory room which is an ongoing idea to embrace all students with behavior, mental health, and trauma issues and those with autism, and provide a whole-child experience and a way for them to express themselves. Ashlee Mischler and Tracy Cooper have been instrumental in creating the room. PTO funds and wellness money have been key to creating the room.

### Superintendent

• Thirty minute later start time. Tecumseh is the earliest starting school in Clark County and one of the earliest in the country. There was a proposed law that schools in Ohio should

- start at 8:30 or later; it is not in effect at this time. CTC will still go at the same time. Would like to begin communication to the community next week.
- Grades 2-5 buildings moving forward. Letters will be going home in the next couple weeks; there will be a Spanish translation. Ivan Gehret is working with staff.
- There will be intradistrict open enrollment and a policy will be presented to the board.
- Lifetouch we are in year 2 of a 5-year contract. The middle school yearbook is in year 3 of the contract. We are looking at other companies. Concerns have been shared regarding sports pictures.
- Academic growth Next year there will be a social studies grade 6-8 adoption with a six-year technology license and workbooks. Beth Moore is working on strategies to align literature with social studies teachers at the middle school. She is also working with English Language teachers at the high school and 6<sup>th</sup>, 7<sup>th</sup>, and 8th grade math and science teachers on alignment of curriculum and common formative assessments.
- The Optimist Speech Contest was held a couple weeks ago. A middle school student will be going on to district.
- The Rotary Speech Contest is coming up with several of our students participating.
- Mental Health Social and Emotional Learning Summit was held today in Columbus.
   Several of our guidance counselors, mental health therapists, and principals attended.
- Vicki Landes at Donnelsville Elementary started a non-perishable take-home meals program for students at Donnelsville, and Jen Priest is spearheading it for the middle school.
- 'Don't Give Up' signs are up around the main campus.
- SOS, Signs of Suicide will be giving a screening.
- EdChoice Bill is still on hold.
- Board policies and administrative guidelines related to food service. Ivan Gehret is looking at it to align policy to the guidelines.

#### Treasurer

- Followed up with the state auditor regarding the new fund for meal charge donations. No response is received to date.
- Southwest Region Spring Conference If board members plan to attend, Denise Robinson needs to know by March 3.
- The state software system used by the district is being re-designed. Training for Tecumseh and Greenon will be done on three Tuesdays in October and one in November. The treasurer and staff will attend those days all day. Dual processing will be required in both systems for four weeks. All districts have to do this. PC's are required for this accounting work.
- In June 2018, we had to do a pay skip. July 30, 2021 will require another pay skip. We can only have 26 pays in a contract year. Information will be provided as it gets closer to July 2021.

#### Assistant Superintendent

- We will hire some summer help positions for moving, moving, and maintenance.
- Mental Health Social and Emotional Learning Summit Governor Mike DeWine reiterated that he is committed to funding for student wellness as long as he is Governor. Watched a video called "In Their Voices" about students' needs and talked with Dr. McFarland who will make the video available to everyone. All the sessions were videoed and will be online.

- There is a grant available through the Mental Health and Recovery Board we can participate in and it is being investigated.
- The Clark County Sheriff's Department and Clark County ESC are looking to team up for a federal grant aimed at finding out information off social media. There is a meeting tomorrow and Denise Robinson will represent Tecumseh. It is a 3-year grant for \$750,000 that could be split between entities.
