## Planning and Discussion

The board conducted a work session to discuss the following:

## Superintendent Paula Crew

- Cost Containment List the overall effect of cuts and attrition from positions being vacated but not replaced is \$339,000 annually or \$1.695 million over the five-year forecast.
- Student Wellness and Success Funding Plans these are restricted funds that can only be
  utilized to help students with their physical, mental, or emotional health, or their physical
  safety.
- Elementary and Secondary School Emergency Relief funding Learning Recovery /
  Summer Learning Program will utilize these funds. Programs purchased will be able to be
  used by all students over the next several years, not just during this six-week program.
- Fallon Survey Discussion results were reviewed regarding the likelihood of a levy being passed.
- Levy Plans a levy recommendation will be made after the five-year forecast is given. A
  levy committee is being formed. We need sustainability, we need new money, but it will
  be an uphill climb. The last new operating continuing money was passed in 1977, and it
  has been since 1995 that we received any additional money by way of an emergency levy.

The board completed an OSBA training entitled The Dirty Dozen – Twelve Tips for Staying Legally Compliant.
