August 9, 2022

The Tecumseh Local Board of Education met in regular session on August 9, 2022 with board president Corinne Scott presiding. Mrs. Scott called the meeting to order at 6:00 p.m. The meeting was held in the Arrow Conference Room at Tecumseh High School, 9830 W. National Road, New Carlisle, Ohio 45344.

Mrs. Scott led the Pledge of Allegiance. Mrs. Scott recognized guests.

Public Comments pertaining to the agenda -

Kerry Cassell - regarding item M, Temporary Substitute Teaching Licenses, asked that we not use parents who have had Children Services referrals made by staff, and that parents not be allowed to sub in their children's classroom. There could be a confidentiality issue when parents have access to teacher's Progress Book information.

Mr. Priest asked a follow-up question regarding Children Services referrals, and who gets a copy of that information. *Mrs. Crew responded that only the person making the referral and herself get a copy of the information*.

Reports:

Paula Crew - Connecting Link went out yesterday, most people received it today. New Teacher Orientation was held last Thursday and Friday. Thanks to those who helped facilitate that meeting. We have a good group of new teachers. Opening Day is Monday, August 15th, you are all welcome to attend. Update on nursing situation that has come about recently. Our school nurses at Park Layne, Donnelsville and Tecumseh High School have left us for various reasons. Working with Dianna Accurso and the Clark County ESC to find replacements.

Brian Dixon and Deputy Loney - continue to work on school safety. Attended a safety summit in Columbus. Governor announced he was adding \$100,000,000 for school safety. We met a 1992 Tecumseh Grad, Ben Suver, who works for the Ohio Department of Public Safety. He put us in touch with a colleague who will help in the grant-writing process. Ben praised Tecumseh for the things we are doing here and wants to bring some

people here to show them what we are doing. Very powerful presentations, the lead detective from Sandy Hook and the principal from Columbine both spoke. 94% of school shootings had information shared with someone else prior to the event. Relationships are very important. This year THS students will enter through only two entrances - the west side of the building where the buses let out and the office doors. The front tower doors will no longer be used. Student workers will not be in the front office anymore. Safety is a work in progress and continues to evolve. *Mrs. Scott asked if the Safety Summit was the first that was held.* -Mr. Dixon replied that it was the first that we have been aware of. *Mr. Priest asked if there are specific things we would like to obtain through the grants.* - Mr. Dixon replied that he is seeing things like security cameras and will work with Ben's contact to make the best use of grant money. *Mr. Stafford was very concerned about the large number of absences when we did the reunification training at the end of May and asked if there was a way to mandate attendance at these types of training. Mrs. Crew replied that we are working on ways to utilize the virtual days to hold trainings, when all staff is at work.*

Mr. Priest - Blown away at the fair by the students, staff, family members, with the support shown to his family. Very proud of New Carlisle and this district and all who are involved in the fair. Hopes that everyone can keep their patience and has a good start to the school year.

Mr. Stafford - echoed Mr. Preist's comments about the fair, his son has shown hogs for years. Thanks to Denise for all the work in preparing and presenting the financial reports.

Mrs. Slagell - extended her sympathies to Deputy Loney on the loss of Deputy Yates. We are glad to have you in our district. Appreciates all the work being done on safety. Proud to be part of this district. Excited for the return to school. Looking forward to a good year.

Mrs. Scott - Tecumseh district has always done well at fair, not just success, but in the support that is shown. Safety and New Teacher Orientation and Substitute Training - other districts look to us to see how we are handling things, then want to copy what we are doing. Thanks to Deputy Loney, we are here to support you. First day of school is a huge process, wishes everyone in the district good luck. Excited to have the kids back in the buildings. CTC - Open House is Monday. Enrollment is slightly down from this point last year. Tecumseh has 114 students planning to attend CTC, second only to Springfield High School.

Ms. Martin - no comments.

PUBLIC COMMENTS

Kerry Cassell - addressed the 60% attendance for the reunification training. Lots of teachers make appointments, as she did, knowing that she won't need to get a sub. Also, the May inservice days typically have a lower turnout than others and there was a lot of teacher burn-out last year. Appreciated Brian sending information out to those who couldn't attend. Hopefully moving forward, it could be done at a different time. *Mr. Dixon replied that we are tied to when we can hold it, depending on the EPA*. Sherry Priest added that reunification should be held first part of the school year, perhaps do away with T-Tech. *Mr. Dixon went over the information at new teacher orientation*.

Regarding bus drivers and sub shortage, asked if Karen Lokai has her CDL license? Mrs. Crew replied that she does not.

Regarding job shadowing, maybe check with teachers, there might be a need to do job shadowing.

Regina Jones - thank you for addressing the sub pay. Would like to see everyone in the district receive a minimum of \$15 per hour. Other districts pay more. Would like the board to look into increases.

Paula Fugate - loss of teachers and staff is a very scary period right now. You can only take so much of the kids' mouths and especially when they are older, with the cursing that is going on. Our teachers are appreciated for all they do. We have a good group at Tecumseh.

Kerry Cassell - (parent) Asked about the technology fee. Is there an option to opt out, since there are families who can afford to provide their own device? Do we get a refund when her child returns his device without any damage? The bad kids are causing every other child to have to pay a fee by destroying devices. Not fair for kids who participate in extracurriculars, they have to have all fees paid before they can participate in extracurriculars.

Regarding using the EPC for the roof, Does Todd get paid by the EPC? Who pays Todd? Is the roofing coming out of PI or General Funds? Mr. Stafford asked about the \$30 technology fee -Mrs. Crew replied that the fee covers insurance on the devices, it won't carry over to the next year. It's not just bad kids who drop chrome books, it can happen to anyone. There is no charge to replace a screen, one time per year. This tech fee is far below what other districts are charging. Sherry Priest, what if kids can't or don't pay fees? Do they still get a device?
